Sub: New guideline for sanction of Annual grant to State Level Associations & District Level Associations for 2014-15 & onwards.

Sir,

The new guideline for sanction of Annual Grant to State Level Associations & District Level Associations for 2014-15 is given below.

New Guideline

- (a) Grant to Sports Associations shall be divided into two categories.
- General Grant (Annual Basis)
 - Special Grant (Case to case Basis)
- (b) General grant, for meeting the general expenses of the Associations to some extent, shall be given only to State Level Sports Associations and District Athletic Associations subject to their fulfilling the terms and conditions.
- (c) Special grant shall be given to various Sports Associations, after thorough examination, on case to case basis, for specific purposes as given below.

Purpose	Grantee
Organization of National Championship in Odisha under the aegis of the recognized National Federation.	State Level Sports Associations
Organization of Special Coaching/ Training camps in Odisha for Players as well as Coaches by National/ International level reputed Coaches.	State Level Sports Associations
Acquisition/ Procurement of sporting equipments to develop sports in the State	State Level Sports Associations
Hosting of All India level Tournaments duly recognized by the concerned State Association and National Federation/ Biju Patnaik Gold Cup Football Tournament	State Level Sports Associations/ District Athletic Associations/ Other Sports Associations.

- (d) The following time schedule should be adhered to for release of General Grant.

| - Intimation to State Level Sports Associations and Districts Athletic Associations for submission of application | - 31 st May |
| - Last date for application | - 30 th June |
| - Scrutiny/ recommendation of the Grants Committee | - 31 st July |
| - Disbursement of grant | - 31 st August |
- (e) Special grant, on receipt of due application from eligible Associations, shall be considered on case to case basis and grant amount, if sanctioned, shall be released accordingly.
- (f) While considering sanction of Grant, General or Special, priority will be given to major competitive sporting disciplines.
- (g) If any conditional sanction is made in favour of any Sports Association for general or special grant, the said Association has to comply the conditions within 90 days from the date of its intimation failing which the conditional sanction will be cancelled and the said Association will lose its claim for receiving annual grant for that particular financial year / special grant for that particular purpose.
- (h) Sporting Associations cannot claim the Grant, General or Special, as a matter of right. Sanction and release of grant will solely depend upon the discretion of the Sports & Youth Services Department.
