OFFICE ORDER

No 2096 /SYS Bhubaneswar dated the 20/02/2014.

Tariff rate for regular use of Sports Infrastructures under the administrative control of Sports & YS Department at Bhubaneswar by the players of different Sports disciplines has been fixed and communicated to all concerned vide this Department Notification No. 4244/ Dt. 02.07.2012, Office Order No.5436/SYS dt.01.08.2012 & Notification No.8558/SYS dt. 25.09.2012. But it noticed that, neither the regular players are depositing the monthly user fee nor the In-Charges of respective Sports Infrastructure are insisting upon the collection of user fee.

It has been ordered that collection of user fee shall be strictly adhered to in letter & spirit with effect from 1st March, 2014 and all the users shall have to deposit the user fee by 7th of each month as per the rate fixed vide Notification No. 4244/ Dt. 02.07.2012, Office Order No.5436/SYS dt.01.08.2012. However, the rate fixed vide Notification No.8558/SYS dt. 25.09.2012 shall only be applicable to the players under going coaching under Government/Departmental Coach.

In order to streamline the collection of user fee **Sri Radha Charan Sethi, Section Officer** and **Sri Dillip Kumar Parida, Sr. Assistant** are attached to Gymnasium-cum- Indoor hall, Saheed nagar and Gymnasium-cum- Indoor hall, Unit-I, Bhubaneswar respectively to collect the user fee in addition to their own duties. They will hold their office for 2-3 hours at their respective Sports Infrastructures from 1st to 7th of each month to collect the monthly user fee and shall issue money receipt to the depositors for which separate Receipt Books have been issued to the In-Charges. They will deposit the collected amount with the Accounts Section of the Department and the details of collection and deposit of user fee shall be maintained in a Register for reference, record and audit purpose. They will also pay surprise visit either in the morning or evening or both in order to ascertain the use of Sports Infrastructures by non-paying players/Assons. and to furnish report to competent authority for further action.

Sri R.C.Sethi, S.O. & Sri D.K.Parida, Sr.Asst. shall be paid Rs.500/- (Rupees five hundred) each towards their remuneration/conveyance for this additional work and the expenditure thereof shall be met out of the Budgetary provision under the unit " O.C. "

This order shall be effective from 01-03-2014.
